

# COMMUNITY PRIORITIES GRANTS APPLICATION GUIDELINES



## About Community Priorities Grants

The Community Priorities Grants Program is the Community Foundation of Lethbridge and Southwestern Alberta's largest granting program. Each year, this fund awards over \$400,000 to qualified donees in Southwestern Alberta. Funding for this program comes from donors across southwestern Alberta that made unrestricted gifts to the Community Foundation. These donors trust that the Community Priorities Grants Committee and Board of Directors will allocate funding to worthy causes throughout the region.

The Community Foundation does not provide Community Priorities Grants to organizations that were approved for grant funding in the previous year. This does not apply to school districts, municipalities, or charities applying in partnership with non-registered groups.

The Community Priorities Fund will not consider requests for funding over \$15,000.

## From Application to Grant

Applications are reviewed by the Community Foundation's Community Priorities Grants Committee, which is comprised of Community Foundation directors and members of the community. The committee considers all applications and makes recommendations to the Board of Directors for final approval. Please note that all applicants are notified, regardless of whether or not they receive funding. Funding is awarded approximately two months after the application deadline date.

## Granting Areas

All organizations applying for a grant must identify which one of the six [Vital Signs](#) Impact Areas their project best addresses:

- Community Connections
- Environment
- Lifelong Learning
- Living Standards
- Healthy Communities
- Cultural Life

## Grant Application Deadlines

Applications to the Community Priorities Grants Program are accepted twice a year, with the following deadlines:

- March 15 at 4:00 p.m.
- October 15 at 4:00 p.m.

NOTE: If a deadline date falls on a weekend, applications are due on the following Monday.

## Applying for a Community Priorities Grant

Before spending your valuable time completing a grant application please read the following information and answer the questions to determine whether your organization and your project meet our eligibility requirements.

---

### Step 1: Is your organization eligible for funding?

Are you located within our region? Our region stretches from the U.S. border north to Arrowwood, and from the B.C. border west to Grassy Lake. You must be located within this region, or carry out programming within this region to be eligible for funding.

Are you a registered charity with **Canada Revenue Agency**?

- The Community Foundation can only grant to **federally registered charities or qualified donees** with a business number (BN). You can check your organization's charitable status by visiting the [Canada Revenue Agency Website](#). Please note that this number is different from an Alberta Societies Number. The Community Foundation cannot fund societies unless they are also federally registered.

## Are you applying in partnership?

If you do not have a CRA BN, you may still apply for funding through a partnership with another registered charity, municipality or school district. If you would like more information on charity/non-charity partnerships, please call the office at 403-328-5297.

## Step 2: Is Your Project Eligible?

**NOT ELIGIBLE** – Please be aware that the Community Priorities Grants Program does **NOT** fund:

- Core operating costs for ongoing programs and services
- General fundraising campaign contributions or sponsorships
- Fundraising events or activities
- Retroactive expenses incurred prior to the final grants decision date
- Deficit reduction
- Advertising and marketing
- Activities that serve primarily the membership or purposes of religious or political organizations
- Seminars, conferences, workshops, festivals, or the publication of studies
- Team or group tours or travel, or travel reimbursement paid directly to individuals
- Projects that do not benefit residents of Southwestern Alberta
- Organizations that received a Community Priorities Grant within the previous year, unless the grant was in partnership with a non-registered organization
- Individuals
- For- Profit Organizations
- Requests over \$15,000

## Step 3: Does Your Project Display the Following Strengths?

The Community Foundation is interested in supporting projects that demonstrate at least one—but typically many—of the following.

The project:

- Fits within at least one of the six Vital Signs Impact Areas
- Helps to fulfill the mission and mandate of your organization
- Improves the services offered by your organization
- Delivers benefits to the majority of the people you serve
- Demonstrates a real need for funding that is not otherwise available
- Demonstrates a search for funding from sources other than the Community Foundation
- Demonstrates an investment in the project through contributions from your organization, the community, and/or support from other funding sources
- Is well developed, achievable within the next year, and:
  - proposes an innovative and practical solution
  - strengthens your organizational capacity or sustainability
  - if applicable, promotes collaboration and sharing among agencies

The Community Priorities Grant will cover:

- One-time costs to build capacity in fulfilling your mission
- One-time capital costs such as equipment purchase, facility construction and renovation projects
- One-time operating costs such as funding to launch a pilot project
- Funding for the initial phase of a program that you can demonstrate will be funded in the future from other sources
- Funding to strengthen the governance of your organization.

## Step 4: Completing Your Grant Application

You can access the grant application through our online [grant management system](#). The application process has two parts:

1. Complete a brief summary of the project by completing the Letter of Intent (LOI)/ Project Proposal. Our Grants Coordinator will contact you to discuss the project.
2. Once the project's eligibility has been approved and the project proposal is ready for submission, you will be invited to complete the full application. The following documents are required to be completed prior to the March 15 or October 15 deadline.
  - Application Form
  - Audited Financial Statement
  - Operating Budget
  - List of Board and key staff members
  - Letter of Support (if applying in partnership)
  - Project Quote

In order for your application to be eligible, you cannot have any outstanding final reports from previous grants prior to the grant deadline. Contact the office if you have any questions about reporting.
